Environmental Problem will impact social stability










4.1.1 "社会行为与环境相互作用"模型

Social behavior is one of the most important variables of the model, there are three types of relation between social behavior and natural environment




4.1.2 "环境治理与政策调节"模型

Different environmental behaviors can be adjusted or restricted by different environmental governance and institutional policies



6.结论与政策建议

Conclusions and Policy Recommendations

- ❖ 结论一:环境保护和社会发展从根本上是一致的。 二者关系处理得好,可以相互促进,处理不好,则 可能相互掣肘,甚至激化各自矛盾。在中国现有发 展水平下,考虑到实现现代化目标的长期性和艰巨 性,必须统筹环保和社会发展,找到二者的"平衡 点"。
- Conclusion 1: Environmental protection and social development are the same in fundamental. Well-treated relationship could make improvement to each other, if not, they will be the barriers to each other even the conflict. Under current development level of China, with the consideration of long-term and difficulties in practice of modernization, it must be organized of environmental protection and social development, finding out the balance.

- ❖ 结论二:环境保护是独立于经济与社会的政策领域。 长期以来,环境保护政策被置于社会发展政策之下。 建立独立于经济政策与社会政策的环境规划与政策 体系,有利于建设生态文明,更好地促进可持续发展。
- Conclusion 2: Environmental protection is a independent policy area from economic and social policy, environmental protection policy has been under social development policy for long term. Constructe an independent environmental planning and policy system is good for ecological civilization construction and improving sustainable development.
